



## 2026 Rendering Healthcare Provider Incentives

Meridian has introduced additional incentives for rendering healthcare providers through the **Pay for Performance (P4P) program**. This initiative recognizes and rewards contracted specialty providers who offer preventive care services to members.

The focus is on key areas such as prenatal and postpartum visits and follow-up care after a mental health hospitalization. Please refer to the table below for rendering provider incentives and associated CPT codes.
