



## **FQHC and RHC -N2 Denials**

## Why am I receiving a denial of EXN2 -Deny: NPI not certified to perform services per state provider file?

RHC and FQHC providers are assigned encounter rates from HFS for services allowed by each clinic.

Federally Qualified Health Center Rates: reimbursement for an FQHC facility is approved by HFS to bill for Medical, Dental and Behavioral Health services. Each clinic may only bill for the services for which they are assigned a rate.
