Earn incentives by screening members for social determinants of health

To promote whole-person care, contracted Meridian Medicaid and YouthCare providers can earn incentives when they screen members for social determinants of health (SDoH) and add Z-codes to claims. Z-codes are ICD-10-CM diagnosis codes used to document SDoH data (e.g., housing, food insecurity, transportation, etc.). Learn how to take advantage of this program, which runs through **December 31**.

Starting **July 21**, Meridian providers can use <u>Availity</u> to update pending authorizations, including service information, diagnosis codes, procedure codes, provider notes, contact information, and attachments. Review our provider notice for details.

Stay vigilant in monitoring potential measles exposure



With confirmed measles cases recently reaching their highest levels in over 30 years, elevated risk of exposure to the disease—especially during the summer travel season—makes it important to stay informed. The Department of Healthcare and Family Services (HFS) recently shared <u>updated guidance</u> regarding coverage of the measles, mumps, and rubella (MMR) vaccine, outlining when an early or extra dose of the MMR vaccine may be appropriate for infants.

Take note: HEDIS medical record submission deadlines

For guaranteed abstraction, providers must ensure timely submission of medical records for Measurement Year (MY) 2025. **New in 2025, providers are encouraged to submit records through Availity**.

- October 31: Deadline to request feedback on medical records
- **December 1**: Medical record submission deadline through Availity or secure provider portals for guaranteed abstraction
