## **Description**

Sodium zirconium cyclosilicate (Lokelma®) is a non-absorbed potassium-binding polymer.

## FDA Approved Indication(s)

Lokelma is indicated for the treatment of hyperkalemia in adults.

Limitation(s) of use: Lokelma should not be used as an emergency treatment for life-threatening hyperkalemia because of its delayed onset of action.

## Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Lokelma is **medically necessary** when the following criteria are met:

#### I. Initial Approval Criteria

## A. Hyperkalemia (must meet all):

- 1. Diagnosis of hyperkalemia;
- 2. Age  $\geq$  18 years;
- 3. Dose does not exceed the following:
  - a. Initial dose: 30 g per day for up to 48 hours;
  - b. Maintenance dose: 15 g per day.

#### **Approval duration:**

**Medicaid/HIM** – 6 months

Commercial – 12 months or duration of request, whichever is less

## B. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

#### **II.** Continued Therapy

#### **A.** Hyperkalemia (must meet all):

1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;

- 2. Member is responding positively to therapy;
- 3. If request is for a dose increase, new dose does not exceed 15 g per day.

**Approval duration:** 

**Medicaid/HIM** – 12 months

Commercial – 12 months or duration of request, whichever is less

## **B.** Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

#### III. Diagnoses/Indications for which coverage is NOT authorized:

- **A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid, or evidence of coverage documents;
- **B.** Emergency treatment for life-threatening hyperkalemia because of its delayed onset of action.
