Meridian is excited to inform you that Centene, the parent company of MeridianHealth (Meridian), has acquired NextLevel Health's HealthChoice Illinois membership. NextLevel Health's membership, which is based in Cook County, moved to Meridian on **July 1, 2020**. We are in the process of notifying members that they will become Meridian members. They will receive their Meridian ID cards shortly after July 1, 2020. NextLevel Health's HealthChoice Illinois contract with HFS concluded on June 30, 2020. All open authorizations for services requested and approved for NextLevel Health members on or before June 30, 2020 for dates of service July 1, 2020 and after will be migrated into Meridian's system to ensure continuity of care. Beginning on July 1, 2020, you can obtain authorizations through Meridian, and claims for dates of service beginning on July 1, 2020 may be submitted to Meridian.
